5. Procedure for Lodging a Complaint

Step 1: Informal Resolution (if appropriate)

- Raise the concern directly with the person involved or a supervisor.
- Many issues can be resolved quickly through open communication.

Step 2: Formal Complaint Submission

If informal resolution is not possible or appropriate:

- Submit a written complaint to the HR Department or submit the complaint in the suggestion box.
- Include your name, contact information, a description of the issue, relevant dates, and any supporting evidence.

Step 3: Acknowledgement & Investigation

- Complaints will be acknowledged within 3 business days.
- An impartial investigation will begin within 7 business days.
- The complainant may be contacted for clarification or additional details.

Step 4: Resolution and Feedback

- A written outcome will be provided within 14—21 business days (depending on complexity).
- If the issue is substantiated, appropriate corrective action will be taken.
